

**CLIMBER AGREEMENT, RELEASE AND ACKNOWLEDGMENT OF RISK
ROCKLIN FAMILY ENTERTAINMENT, LLC
(DBA: STRIKES FAMILY ENTERTAINMENT CENTER)**

In consideration of the services of ROCKLIN FAMILY ENTERTAINMENT, LLC (DBA: STRIKES FAMILY ENTERTAINMENT CENTER), its agents, Owners, officers, employees, and all other persons or entities acting in any capacity on its behalf, I hereby Agree to release and discharge ROCKLIN FAMILY ENTERTAINMENT, LLC (DBA: STRIKES FAMILY ENTERTAINMENT CENTER), on behalf of myself, my heirs, assigns, personal representatives and estate as follows:

1. I understand and acknowledge that the activity I am about to engage in bears known risks and unanticipated risks that could result in injury, death, illness, disease, emotional distress, or damage to myself, to property or to third parties. The following describes some, but not all, of those risks: climbing on, or falling off, the artificial climbing structures, falling to the ground, on other users or being fallen on by other users, abrasions from the walls, ropes, pads, or the floor, equipment failure, belay failure, or climbing out of control or beyond ones personal limits.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify **ROCKLIN FAMILY ENTERTAINMENT, LLC (DBA: STRIKES FAMILY ENTERTAINMENT CENTER)**. BY SIGNING THIS DOCUMENT, I ACKNOWLEDGE THAT IF ANYONE IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN THIS ACTIVITY, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST **ROCKLIN FAMILY ENTERTAINMENT, LLC (DBA: STRIKES FAMILY ENTERTAINMENT CENTER)**, ITS AGENTS, OWNERS, OFFICERS, EMPLOYEES, OR ANY OTHER PERSONS OR ENTITIES ACTING IN ANY CAPACITY ON ITS BEHALF, EVEN IF THEY OR ANY OF THEM NEGLIGENTLY CAUSED SUCH INJURY OR DAMAGE.
